Dear Federation members:

Please note the By-laws regarding the nomination of officers for the Missouri Federation of Women's Democratic Clubs. You may nominate someone or volunteer to serve.

MFWDC By-Laws

Article VII: Section 3

A Nominating Committee consisting of five (5) members shall be elected by the Executive Board at least sixty (60) days prior to the Federation's annual meeting, held in odd-numbered years. No two (2) members of the Nomination Committee shall be from the same district. It shall be the duty of the Nominating Committee to choose a nominee for each office. There shall be at least one elected officer from each district with membership in the Federation. The consent of each nominee must be obtained before her name is placed in nomination.

Letters of recommendation from member clubs on behalf of a nominee(s) will be considered, but the final authority rests with the Nominating Committee. No member shall be considered for the office of President unless she has been a member of the Federation for at least three (3) years. The Nominating Committee shall send a list of the nominees to the Executive Board members and the District Presidents, who shall send the said list to Club Presidents of each member association, at least twenty (20) days prior to the Annual Meeting.
